99.3 THE EAGLE'S "ONLINE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KWIC-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.eagle993.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.3 THE EAGLE's "ONLINE"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries received by [11:59pm] on August 25 will be eligible for the random drawing for the prize. **Limit one (1) entry per person, regardless of how many email addresses a person may possess and use.** Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified.
